# Ekoplast LLC is Ukrainian manufacturer, one of the leaders of polymeric materials production.

Ekoplast LLC was founded on April 28, 2001. The company started its activity with the production of polyethylene garbage bags, and in a few years has considerably expanded the range of household products.

Starting from 2008, the main activity of Ekoplast LLC is a production of polymeric materials: **Cooking sleeves**, **folded and unfolded cooking bags**. Products are manufactured in accordance with the specially developed by our engineers and patented technology with the use of several "know-how".

In addition to this, Ekoplast LLC manufactures **Ties** designed for cooking sleeves and bags, confectionery packing, baking, and other products.

These products are manufactured in accordance with the operational system:

-Quality control management, which corresponds to ISO 9001 standard: 2015;

-Food Safety Management (ISO/TS 22002 – 4:2013) which complies with the certification Scheme FSSC 22000:2011;

#### Chapter 2: General Information. Quality, Food Safety and Ecology.

The integrated system of quality management and food safety (hereinafter - ISO) successfully functions in Ekoplast LLC since 2014. ISO undergoes re-certification and annual audits, conducted by the international certification bodies, once in three years. In 2018, Ekoplast LLC has successfully passed audit of the ISO and became certified according to ISO 9001:2015 "Quality Management Systems Requirements" and ISO/TS 22002-4:2013 «Programs of preliminary requirements for safety of food products. Part 4. Production of food products packaging», FSSC 22000 edition 4.1. «Requirements to the Food safety certification system». The audit was conducted by Ukrainian representative of international certification body - QSCert, Spol. S R.O.-OSCert-Ukraine B.V.

During the audit in 2018, the main focus of the auditor was aimed at compliance of Ekoplast LLC ISO with requirements of PAS 96:2017 "Guidance on protection and safety of food and beverages from criminal acts", new requirements of FSSC 22000

edition 4.1, as well as analysis and plan of measures against threats (TACCP), vulnerabilities (VACCP) and dangers (HACCP) for food safety, prevention of bioterrorism in all phases of the ISO functioning. Given the new requirements, in the beginning of 2018, the number of ISO procedures were substantially revised, amended or published in new editions.

#### results Based the on consideration, the auditor of QSCert-Ukraine B.V. defined the procedures and implemented measures, developed in Ekoplast LLC, as effective. Audit was successfully passed and Ekoplast LLC

gained new certificates.

In order to improve information sharing within the of organizational management, the system automated systems Microsoft Office 365 and cloud-based communication tools were implemented in Ekoplast LLC in 2018.







#### **Quality of Products**

Quality and food safety are among of the priority aspects for Ekoplast LLC. Therefore, all raw materials, goods and all the manufactured products for our customers are obligatory checked by our QC department. The received services that according to HACCP analyses are



defined as such that may contain risks for quality and food safety of products (e.g. water supply, washing clothes, garbage removal, high-rise structures, and tests conducted in accredited laboratories, etc.) undergo periodic safety assessment of their efficiency and quality. This inspection involves QC department specialists and HACCP group members.

The average value of products quality released in 2018 was determined at the current and receiving control and had a result of 99.99%. The monthly measured values are represented in Diagram 1.

#### **Food Safety**

As a part of the current risk analysis procedures "HACCP", "TACCP" and "VACCP" precautionary measures, aimed at reducing the likelihood of risks and reducing the consequences of their appearance, were developed and implemented in 2018. As a part of this, tests of manufactured products, raw materials and microbiological factors were conducted in the following accredited laboratories:

- Scientific Center of Preventive Toxicology, Food and Chemical Safety of the Ministry of Healthcare of Ukraine (Ukraine),
- Etalon (Ukraine),
- Khmelnytskyi Regional Laboratory Center of the Ministry of Healthcare of Ukraine (Ukraine),
- ANMAT (The national administration of medical drugs, food and medical technology), Argentina.



The purpose of the periodic tests in 2018 was to prove compliance of Ekoplast LLC products with the requirements of the legislation of Ukraine and MERCOSUR countries, which regulates polymeric packaging contact with foodstuffs, as well as risks control for food safety from the raw material and production environment. The results of the test protocols confirm compliance of Ekoplast LLC products with the



requirements of the legislation of mentioned countries in food safety field.

In 2018, Ekoplast LLC has adopted and approved POLITICS OF KOPLAST LLC on management of received services, labeling and prevention of falsification, protection against products bioterrorism, as well as for the control of allergens and the state of the production and natural environment, use of marks for goods and services. Several procedures have been updated in accordance with the new FSSC 22000 requirements in preventing from fraud and tampering, with the respect to raw materials and manufactured products.

#### **Preservation and Protection of Environment**

In 2018, Ekoplast LLC made some improvements aimed to protect the environment.

Ekoplast LLC has the official documented list of the wastes, accumulated and transferred to recycling and licensed elimination.

In 2018 in the production and storage premises of Ekoplast LLC all fluorescent lamps with mercury were replaced by LED lamps.

In 2018, Ekoplast LLC successfully passed planned state check on compliance with the requirements of legislation in the field of environmental protection, rational use, reproduction and protection of natural resources. Check was conducted by the State ecological inspection in Khmelnytskyi region. Chief specialist of Department of State Ecological Supervision (control) of water resources and ecological air atmospheric of State inspection in Khmelnytskyi region honored Ekoplast LLC for high efficiency of work on environmental protection.





#### **Chapter 3: Our Employees**

Ekoplast LLC constantly has 70 employees.



We invariably follow the principles of corporate social responsibility - we are eager to attract, nourish and retain talented employees thanks to the following:

- Protection of their health and welfare;
- Creation of safe working conditions;
- Establishing open and honest relationships;

The indisputable rule of doing business for Ekoplast LLC is a clear observance of all requirements of current legislation and fulfilling all government requirements for social security in the relationship between the company and its employees, in particular the Labor Code.





Ekoplast follows the principles of gender equality, which provides equal possibility of personnel recruitment, unless otherwise contradicts the current legislation of Ukraine, career promotions and senior management position assignments.



We also do not assume discrimination against persons with disabilities. If, according to the medical institution conclusions, a person can perform work and fill the vacancy - we settle a workplace according to the conclusions of an individual rehabilitation program for the person with disabilities.



Ekoplast LLC Invites and hires not only youth and students. Among all employees, the age category from 30 to 50 years old constitutes 56%. They are the experienced managers and professional workers who have a professional background, creativity, intellectual flexibility, interest in their business. Therefore, they are ready to convey their experience to the younger generations of employees of relevant professions and positions.



For permanent support of proficiency maintaining at the decent level, Ekoplast LLC organizes and directs the personnel to study the newest Ukrainian and international conducting business practices.



During 2018, 15 employees completed trainings in the following fields:

In terms of increasing requirements to the level of qualification of the personnel, one of the important tasks remains to ensure the continuous process of staff training at the workplace.



During 2018, our employees had internal studies, at workplaces, namely the briefings. They took part in trainings in general for 20 subjects, where employees of all company departments were involved in accordance with their qualification and functional direction.

However, in our production department mentoring is widely used. Experienced workers convey the experience and knowledge to new employees, who need professional trainings, so they can form the necessary skills.



We also practice elearning. Employees themselves regulate the time they spend to study, based on the list of necessary topics planned for a certain period (quarter, half of the year). The electronic library is uploaded the to available electronic resource. which allows training at the workplace at a convenient time. Ekoplast LLC has a small library

where employees can read books in their spare time. They can also fill the library with literature, which would be useful in work or just interesting to colleagues. Ekoplast welcomes the aspiration of personnel to selfeducation, realization of own ambitions and potential. Initiative employees, who have the desire to learn, ready to develop both professionally and in personal terms, always have the opportunity for self-development. Owing to this, such employees are not only self-taught, but also share interesting experiences with colleagues in discussions and consultations about the innovations while having a cup of coffee.





#### Section 4: Labor Protection, Fire Safety and Civil Protection

In accordance with the law of Ukraine "On Labor Protection", management of Ekoplast LLC provides labor protection and fire safety for organization and execution of legal, organizational-technical, sanitary, hygienic, socioeconomic and preventive measures, aimed at prevention of accidents and occupational diseases in the work process.

In its activities, Ekoplast LLC adheres to the following position: "Fire safety and labor protection are closely intertwined and interconnected spheres."

An engineer of labor protection is a responsible person for labor protection at Ekoplast LLC. For fire safety the specially trained specialist is appointed from the staff of Ekoplast LLC. Director of Ekoplast LLC heads the service of civil protection of the company.

In 2018, the main goal of the Ekoplast LLC was to enforce the company's policy in the field of quality, food safety, labor and environment protection, as well as compliance with norms, standards and requirements on labor protection, fire safety and civil protection.

Main directions of Ekoplast LLC work on labor protection and fire safety in 2018:

- ✓ ensuring safe working conditions and fire safety;
- ✓ conducting briefings to structural divisions of the company on labor protection, fire safety and civil protection;
- ✓ improving the functioning of the labor management, fire safety and civil protection system;
- ✓ formation of preventive culture of the company's personnel on fire safety, civil and labour protection, decrease the probability of accidents in production and non-production areas;
- ✓ implementation of measures (provision of special clothes, detergents, etc.) according to certain normative and legal acts;
- ✓ seeking new approaches to address the issues of labor protection, fire safety and civil protection.

On an ongoing basis, introductory briefings on occupational safety, fire safety and civil protection are provided with the involvement of specialists of specialized institutions.

Thus, in March 2018 the Educational and Methodical Center of Civil Protection and Vital Activity Safety in Khmelnytskyi region conducted training on fire safety for the staff of Ekoplast LLC.

In May 2018, the fire safety training was held for Ekoplast LLC staff by the specialists of State Rescue Service "101". In order to maintain an adequate level of fire safety, all fire-fighting equipment has been serviced and certified by a specialized agency.

During 2018 in the structural subdivisions of the company consultations on issues of clarification of current regulations on labor protection, prevention of traumatism in the production sphere and in everyday life, rules of conduct in case of an emergency were conducted.

In May 2018, the specialists of the State Institution "Khmelnytskyi Regional Laboratory Center of the Ministry of Health of Ukraine" conducted the certification of the following jobs at Ekoplast LLC:

- ✓ Locksmith-Electrician for the equipment repair;
- Locksmith of machine-assembling;

✓ Assistant machinist of automatic production line of polymer containers;

✓ Storekeeper;

✓ Packager;

✓ Production premises cleaner;

✓ Subsidiary worker;

According to the results of the certification, these jobs are defined as having normal working conditions. Namely:

 $\checkmark$  Good condition of machines, machine tools and devices;

 $\checkmark\,$  Proper quality of materials and tools, necessary for work process;

 $\checkmark$  Timely delivery of electricity, gas and other sources of power to the production site;

✓ Provision of technical documentation;

 $\checkmark$  Harmless and safe working conditions.

In order to improve working conditions in production premises of Ekoplast LLC, in March 2018 the complex of works was carried out to raise the temperature of air on the production site during the cold season. The management of the company allocated about 143 thousand UAH to build the buffer gate. An additional infrared heater was installed.

At the beginning of June 2018, along with a production premises, benches and equipped recreational facilities were installed for the rest of the staff.

In accordance with the terms of collective agreement between Ekoplast LLC and its employees, in 2018 all the workers were provided with special clothes. In the second quarter of 2018 new special footwear for production personnel was purchased.

In accordance with the requirements of the legislation, Ekoplast LLC carries out insurance of its employees from accidents and occupational diseases. The enterprise pays the Single Social Contribution in the amount of 22% to the amount of the accrued wage by type of payment, which includes the basic and additional wages. Ekoplast LLC has all necessary authorization documents in accordance with the requirements of Ukrainian legislation in the sphere of labour protection, fire safety and civil protection. Equipment, machines, mechanisms and the



tools, used in work, correspond to their passports, undergo the required scheduled technical inspections, as well as periodic verifications and controls by the food safety team, following the observance of the safety rules of the workers during their operation.

Due to the joint and purposeful activities of the structural units in 2018 there were no cases of occupational injuries and fires.

In March 2019 Ekoplast



LLC is going to successfully pass a social responsibility audit, during which the main attention will be paid, among other things, to the issues of occupational safety, fire safety and civil protection.
